Candidates in East Gippsland sign Science Pledge

A science pledge was recently circulated to the large field of candidates in the East Gippsland Shire Elections by Peter Gardner. Gardner, also a candidate in the election, copied the pledge from Shawn Otto's book The War on Science held by the EGS Library. Otto noted that "Science is our very best tool against prejudice and unexamined attitudes..."

There are five major proposals in the pledge but the main purpose of it is to base shire decision making on evidence and best science. That public-policy decisions are based on "well-established evidence produced by science" and NOT by personal opinion, political objectives, ideological positions or economic interests. It is probably the latter that holds sway in local government at the moment.

Six candidates have signed the pledge to make a "commitment to science and evidence as the foundation of the democratic process" and "as the basis for sound, effective and equitable public policy." They are Jes John of Bruthen, Deb Foskey of Bonang, Jackson Roberts of Bairnsdale, Jeremy Schroder of Paynesville, Catherine Pirrie of Mallacoota and Gardner, formerly of Ensay and now resident in Bairnsdale.

I have signed a science pledge, which requires me, if elected, to vote according to the best evidence available, based on science and knowledge. I hope to circulate the pledge to other candidates in East Gippsland and encourage them to sign it.

Science Pledge

A renewed commitment to civic leadership based on the principles of freedom, science and evidence.

Whereas democratic countries have accomplished great things by setting freedom, knowledge, and science as the basis for sound, effective and equitable public policy;

Whereas preserving freedom and solving policy challenges requires elected leaders to make a renewed commitment to science and evidence as the foundation of the democratic process;

I hereby pledge that:

PUBLIC DECISIONS MUST BE BASED ON EVIDENCE I will support public-policy decisions based on well-established evidence produced by science, which may be informed by economic interests and personal values but never superseded by personal opinions or political objectives.

KNOWLEDGE MUST NOT BE SUPPRESSED I will protect and defend the basis of freedom – the scientific consensus of knowledge – against political forces that seek to deny it, suppress it, or substitute for it rhetoric or opinion.

SCIENTIFIC INTEGRITY MUST BE PROTECTED I will oppose all efforts to reduce freedom by holding back or altering scientific reports or evidence that conflict with personal opinion, ideological positions, economic interests or political objectives.

FREEDOM OF INQUIRY MUST BE ENCOURAGED I will oppose acts that attack, intimidate, prosecute, disparage, or silence scientists and academics whose research or reports conflict with personal opinions, economic interests or political objectives.

MAJOR SCIENCE ISSUES MUST BE OPENLY DEBATED To demonstrate my commitment to these principles, I will participate in one or more substantive, nonpartisan, public, independently moderated debates on the science issues I may encounter if elected.
