## A.Statement of Council Candidate

## If elected I will

- 1. move the shire should immediately appoint a 'carbon officer' whose first task should be to carry out a 'carbon audit' of all shire activities.

# CLIMATE CHANGE - WHY URGENT ACTION IS REQUIRED

A recent World Wildlife Fund (WWF) study has doubled the sea level rise predicted last year by the Intergovernmental Panel on Climate Change (IPCC) illustrating the need for urgent action. The IPCC predicted that by 2100 sea levels would rise by .6m whilst the WWF study has estimated that the rise will be closer to 1.2m by this date.

A number of prominent scientists including CSIRO adviser Barrie Pittock and James Hansen of NASA have been warning for some time that the IPCC predictions may be underestimates and that the sea-level rise may be even higher than the WWF estimate.

Early indications suggest that events are occurring at the upper level of IPCC predictions especially in the case of the extent of summer ice in the Arctic. In the last two summers the Arctic ice has declined dramatically leading some to predict that the Arctic may be ice free in summer within a few decades. Warming in the Arctic circle is much stronger than elsewhere on the planet.

A recently study on the effect of climate change and subsidence by the Gippsland Coastal Board discusses the possibility of a broach of the barrier of the 90 mile into the Gippsland Lakes which could be disastrous for all the communities around the lakes. The sea level rises analysed in this report are based on the 2007 IPCC report and may be substantial underestimates. The WWF report indicates that events such as sea-level rise may be "faster, sooner (and) stronger".

Agreement and action is urgently needed at all levels of government and across the political spectrum. A large number of actions can be taken in the local government area including conservation of energy, using a variety of forms of local electricity generation including solar, wind, and biofuels (waste powered) and the large-scale planting of trees on shire land to offset the carbon the shire produces. A number of other practices can be implemented to adapt to the predicted changes - one example being the management of roadsides in co-operation with farmers to remove fire hazards from around towns and roadsides. The hazardous material removed should be used to produce electricity and possibly agrichar - a stable form of charcoal to be used as a fertiliser.

Whilst the challenges that global warming poses are momentous we will be far better off if we face them squarely and start working on them now.

#### FARMERS CAN BE WINNERS IN CARBON TRADING

Tim Flannery noted in a recent publication ("Now or Never"Quarterly Essay) that farmers can earn money from tackling the problem of climate change.

Amongst the many suggestions he made was the use of pyrolysis or micro generators on farm to burn waste to produce a gas that can either be used to generate electricity or make liquid fuel. These generators are sophisticated versions of the 'gas producers' used to power vehicles during World War 2. As well the generators also produce charcoal - called "agrichar" and "biochar" - which can be returned to the soil with fertiliser.

This has a number of advantages including the sale of 'carbon credits' and helping retain moisture in the soil. As a "carbon sink" putting charcoal back in the soil is even better than planting trees as the carbon is stable and will last thousands of years.

The reason why these machines are not being widely used at the present as they are too expensive for individual farm operations. The Shire can test the running and viability of these generators for farmers and others.

The shire is suitably placed to purchase a small pyrolysis generator and use it as part of their waste management program. As well strategically placed generators - operating at local tips for instance - can be used to burn hazardous material from

around towns and along communications routes to provide protection against the predicted increase in numbers and intensity of bushfires.

### HISTORIAN TO RUN ON GLOBAL WARMING

Gippsland historian and bookseller Peter Gardner has announced his candidature for the East Gippsland Shire Council.

Gardner is running on the single issue of global warming and for governments acting decisively on the problem of climate change.

"Much urgently needs to be done at all levels of government" Gardner said. Gardner is calling for the shire to immediately appoint a 'carbon officer' to make a thorough 'carbon audit' of shire activities and for the Shire to aim to become carbon neutral in four years time or less. The role of the carbon officer should be to help achieve this as well as educating the community and council on the all aspects of climate change.

Gardner noted "Farmers and landholders should be one of the main beneficiaries of the carbon trading proposals and hopes that the shire will lead the way for them in the use of microgenerators, alternative energy, agrichar, establishing carbon sinks and roadside management.

The candidate claims that his own business is 'carbon neutral' as he plants, nurtures and protects a number of trees each year to offset the carbon dioxide he produces in the normal activities of his business.

Gardner has also been a strong supporter of alternative energy and has lived in a solar powered house for more than 20 years.
